Wisconsin GI Bill	<p>If you were a Wisconsin resident when you joined the military, or if you have lived in Wisconsin for five consecutive years, you may be eligible for the WI GI Bill.</p> <input type="checkbox"/> Submit Form 2029 to BTC’s School Certifying Official <input type="checkbox"/> Submit Certification (Form 2031) for WI GI Bill – provided by email from the State
National Guard	<p>For members of the National Guard, Wisconsin National Guard Tuition Grant Application</p> <input type="checkbox"/> Submit DMA Form 189-E – <i>this form needs to be completed each semester</i>
